- 1. The School will submit its unaudited financial data to the Minnesota Department of Education as outlined in Minnesota Statute 123B.77, Subd.3.
- 2. The School's Board Resolution must acknowledge that if the deviation is granted, the School is required to complete the external audit in the subsequent fiscal year that includes both that year and the prior year's (delayed) financial activity.
- 3. A Charter School's UFARS file submission requirement is still in effect, regardless of whether an audit deviation is approved. As in all other years, a School's UFARS file submission includes all financial activity from local, state, federal and private funds from outside sources. The Charter School's Board Resolution must confirm the Board's understanding that the Charter School will submit UFARS data file as required by law and the UFARS manual documenting all account activity.

4. The Charter will continue to actively seek an Auditor to ensure that an audit for fiscal year 2023 is completed as quickly as possible.

The members of the Progeny Academy Board of Directors understand the requirements and responsibilities that are involved in this Request.
