6.1 Monthly Reports and Payment Registers (Ms. Nelson presenting)

Fund 01

- As of November 30, 2024 the school has received in Fund 01 a total of \$596,370 of current Fiscal Year State, Federal, and Local revenues which is 33% of its current budgeted amount.
- As of November 30, 2024 the school has expended in Fund 01 \$597,556 which is 34% of its current budgeted expense.
- Progeny Academy ended November 2024 with a current fiscal year to date Fund 01 deficit balance (revenues received less expenditures incurred) of \$11,186.

Fund 02

- As of November 30, 2024 the school has received in Fund 02 a total of \$12,418 of current Fiscal Year State, Federal, and Local revenues which is 14% of its current budgeted amount.
- As of November 30, 2024 the school has expended in Fund 02 \$24,289 which is 21% of its current budgeted expense.
- Progeny Academy ended November 2024 with a current fiscal year to date Fund 02 with a deficit balance (revenues received less expenditures incurred) of \$11,871.00.

Additional Notes

- A. Progeny Academy had a total cash balance of \$186,866 at the end of November, 2024 reflected across all funds.
- B. Progeny Academy, District 4263 had a balance of \$33,978 in accounts receivable at November 30, 2024.
- C. The Fund 2 Balance is subject to a one to two month lag in submission and receipt in funding.
- D. Progeny Academy had an overall audited fund balance of \$241,194 at June 30, 2024.
- E. The school was paid on 85 ADM or 89.8 Pupil Units in July of 2024.
- F. The Board also reviewed the payment register for the month.
